

2022 UPDATE


HIGHLIGHTS

- LIA partnered with the Lake Iroquois Recreation District (LIRD) to apply for an receive a matching grant from Watersheds United Vermont (WUV) for implementation of stormwater improvements on Beebe Lane
- The Lake Iroquois Association also applied for Congressional Directed Spending funds through Senator Bernie Sanders office
- Their office selected the project as one of several sent forward to Congress for consideration and inclusion in project funding for the next fiscal year
- We hope to hear of a successful award sometime in 2022

HIGHLIGHTS

- 2021 Co-awardee of a Lake Champlain Basin Program Watershed Action Plan grant
 - Partnering with the Winooski Natural Resources Conservation District & Lewis Creek Association
 - Purpose is to assess problem areas and develop project sheets identifying corrective action
 - Engineering firm SLR chosen and project work moving forward

Lake Wise Awards

- VT DEC-sponsored program that encourages landowner improvement of shoreline buffers
- 5 additional shoreline property owners awarded in 2022 for 11 total
- 15% of total lake properties awarded achieves Lake Wise Gold status
 - (14 out of 92 total properties)



AQUATIC INVASIVES MANAGEMENT

Eurasian Watermilfoil

- Channel markers to maintain clear boat channel
 - None needed

Diver-Assisted Suction Harvesting (DASH)

- None required due to near zero absence of milfoil
- Some hand pulling in southern end of lake
- Benthic Mats
 - None emplaced this year due to milfoil absence

GREETER & BOAT WASH PROGRAM

Program supported by an Aquatic Nuisance Control grant from VT DEC, funds from the Towns of Hinesburg and Williston, membership dues and donations, water supplied by the Hinesburg Fire Department, and volunteer hours from LIA members

Objectives

- Prevent aquatic invasive species from entering or leaving the lake
- Educate watercraft users verbally and via distribution of educational pamphlets on invasive species
- 2019: 800+ watercraft inspected
- 2020: 1,608 watercraft inspected more than double the number from previous year
- 2021: 1,486 watercraft inspected
- 2022: 2,263 watercraft inspected

DATA COLLECTION

Lake Iroquois tributary sampling

- Supported by a LaRosa Partnership Program Grant
- Sampled 10 tributaries for phosphorous and some for chloride
- Funding continues to be flat relative to expanding number of partners
- 2 Aquatic Plant Surveys June 6th and one scheduled in September
 - No milfoil detected in June; small clumps detected later in the summer
 - Curly-leaf pondweed (Potamogeton crispus) only invasive found; Lake Champlain has 51 by comparison

CONSERVATION

Loon Restoration Project

- Managed by Erick Hansen of the Vermont Center for Ecostudies
- LIA Board member Jack Linn worked with Chip Wright to set up and maintain loon nesting platform and signs warning of loon nesting activity
- Another successful nesting year for loon pair
- Former LIA Board member records loon activity with Lake resident participation



ICE-OUT CHALLENGE

Held 2nd Annual Ice-Out Contest January-March 2022

- Participants guess the date and time when a concrete block will break through the ice on Lake Iroquois, Vermont, with a chance to win 50% of the pot
 - Purpose is to elevate awareness of Lake Iroquois and create a means to incrementally fund shoreline protection efforts
