Hi Taylor

You may recall that this NRBC grant is associated with an expansion of water/sewer into the Richmond gateway, specifically for the historical Willis farm now owned by the Reaps. The short version is that we could not come up with a financially viable approach to extending the line(s).

While many (not all) of the gateway residents/property owners were interested in accessing public water and/or sewer, the high costs of extending the line(s), connecting to them, and then paying user rates/fees has been prohibitive for the small number of properties. One property owner recently invested in a costly septic replacement, which would represent stranded investment costs should the lines be extended. I note that our w/s rules specifically state that extensions will only be made if paid for by the new users/customers (ie not the current users/customers).

There were some secondary wrinkles associated with line(s) passing through the school property and the conserved land between the school property and the Reap property.

At this point the Reaps are constructing storage units at the rear end of their property, near the highway. Obviously this reduces their need for water/sewer and their interest in accessing the public systems.

Further down the road, literally: At one point the owner of the mobile home park (Mr. Brown) expressed some interest in connecting to public sewer but was daunted by (a) the cost of extending

the line, (b) the fact that the public water sewer system would not take over the antiquated septic lines within the park, including installation of individual meters at each property, and (d) the challenges of exploring expansion of the park as a quid pro quo, which involved zoning and DRB separate from the water sewer commission, and for which at the time he seemed to anticipate town-funded installation of water/sewer lines and service.

Including Morgan Wolaver, current chair of the water sewer commission, and David Sander, current chair of the selectboard.

I am alerting you that we have a 4th Chittenden Co NBRC investment that is on the cusp of deobligating their award. Prior deobligations and/or projects in jeopardy funded in Chittenden Co include the **City of Winooski**, the **Town of Richmond**, the **Town of Westford**; the present-day example is the **Town of Hinesburg**.

**City of Winooski** = Catalyst 2019 \$450,000 for underground infrastructure – power and telecommunications for Main St revitalization project **Town of Richmond** = EID/EDA 2021 \$147,947 for extension of ww infrastructure

**Town of Richmond** = EID/EDA 2021 \$147,947 for extension of www intrastructure **Town of Hinesburg** = Catalyst 2022 \$460,020.00 for well #6, drinking water capacity

Town of Westford = EID/EDA 2021 \$466,194 for public WW capacity
TOTAL = \$1,524,161

We have lots of municipal partners, in much more rural areas, that are managing contributions of federal funding to their municipally lead infrastructure projects. It would be great to collaborate on how we could collectively buck this trend.

We saw a lot of interest from Chittenden Co in the Spring 2024 cycle; 5 preapplications totaling \$3.375 were received. Two of the Chittenden Co pre-applications were invited forward to apply, which are in the 19-application portfolio currently under review.
